### 5.0 SELECTION;

Applications for admission will be screened and shortlisted by a committee specially constituted for this purpose. The training centre will prepare merit list based on the pre-interview scores. Based on the quota of seats, candidates will be called for interview, Final merit list will be prepared based on the scores obtained by the candidates on the basis of academic qualifications and interview. Mere submission of the application form will not entitle the candidate to be called for interview.

## 5.1 Caste Certificate:

In case of SC, ST and OBC / SEBC candidates, the Caste Certificate should be issued by the concerned Tahsildar / Additional Tahsildar. The Caste Certificate shall be considered by virtue of birth only.

## 5.2 PWD Certificate:

The candidates are required to submit PWD Certificate issued in their favour in the prescribed form by Medical Board countersigned by CDMO.

6.0 DURATION: The duration of the Course is two academic years.

### 7.0 NUMBER OF THE SEATS:

35 candidates will be admitted to the course at the training centre per year.

Note: In case of non-availability of candidates in one of these categories, seats will be filled up from the candidates of the General Category
